

East/West Institute Access to Justice Program (Phnom Penh, Cambodia)

Atif Ahmed Choudhury (1L) will serve as a member of EWMI's Rights and Justice team, working with Cambodia's most marginalized citizens on land and resource issues. He will also be a member of the Counterfeit Pharmaceuticals Prosecution Program, which works on stemming the flow of illegal pharmaceutical products in Cambodia.




Center for Human Rights and Environment (Cordoba, Argentina)

Callie Carnemark (1L) will work with CEDHA's Glacial and Mining Groups, focusing on fracking issues. CEDHA operates according to the principle that environmental degradations create human rights violations that are cognizable under international law.

**Khulumani Center for Truth, Reconciliation and Reparations
(Johannesburg and Cape Town, South Africa)**

Vahid Deiwakh (1L) will help mediate sessions between victims and offenders of apartheid. His research will focus on the outcome of a fund established for victims of a 1996 bombing in Worcester and how victims can petition the government for redress of their grievances.





Women's Rights Center (Warsaw, Poland)

Daniel Chandler (2L) will be working on issues of domestic abuse and human trafficking. The Women's Rights Center of Warsaw serves as a human rights watchdog for Eastern Europe, providing care for victims when prevention strategies fall short.



International Bridges to Justice (Geneva, Switzerland)

Nadia Abramson (1L) will be working on issues relating to pretrial detention abuses, including torture and the absence of legal representation. IBJ is an international human rights organization promoting basic human rights in criminal justice systems of developing countries.




Beijing Children's Legal Aid and Research Center (Beijing, China)

Kylie Madsen (2L) will be doing comparative legal research exploring the differences between legislation impacting children in different regions of the world. She will present her work to organizations in Beijing at the conclusion of her internship.

International Institute for Democracy and Electoral Assistance (The Hague, Netherlands)

Adama Sirleaf (1L) will work with IDEA's Constitution Building Processes Programme, which provides technical assistance and knowledge resources to national actors engaged in post-conflict constitution building processes.



International Development Law Organization (Rome, Italy)

Morgan Fletcher (2L) will be working in IDLO's home office on law and development issues relating to South Sudan. IDLO works with governments and citizens around the world to reform and rebuild their laws and justice systems to promote peace, justice and sustainable economic development.

East West Institute Access to Justice Program (Baku, Azerbaijan)

Nadja Wolfe (2L) will be assisting in creating legal frameworks for civil participation in governance and rural economic development.



**Center for the Study of Violence and Reconciliation
(Cape Town, South Africa)**

Fahimeh Manjili (1L) will be working with CVR's Transitional Justice Programme, which works to promote peace and human rights in post-apartheid South Africa.



International Bridges to Justice (Phnom Penh, Cambodia)

Daniel Ginnetty (1L) will assist in organizing legal training sessions and rights awareness campaigns, while also helping to provide legal advice to Khmer citizens. Since virtually all of Cambodia's intellectuals were killed during the reign of the Khmer Rouge, the country still suffers from a significant shortage of lawyers.

**National Center for State Courts International Programs Division
(Arlington, Virginia)**

Christian Schreiber (1L) and **Amanda Hamm** (1L) will work on international judicial reform and governmental accountability issues. NCSC is a private non-profit organization providing technical assistance, training and technology to advance justice systems worldwide.



People Against Suffering, Oppression and Poverty (Cape Town, South Africa)

John Palenski (1L) will be working on a team that protects and promotes the rights of refugees, asylum seekers and immigrants in South Africa. PASSOP creates and strengthens networks of communication, dialogue and interchange for the advancement of peace, understanding and justice in local South African communities.



International Finance Corporation (New Delhi, India)

Gowri Janakiramanan (2L) will be working on loans and equity investments in IFC's New Delhi office. IFC is a member of the World Bank Group working to advance economic development by investing in commercial projects that help reduce poverty.

U. S. Embassy (Tokyo, Japan)

Ann Zachariah (2L) will be working for the U.S. State Department in Tokyo, part of the U.S. Mission in Japan that aims to foster U.S. – Japanese relations, provide services to American citizens in Japan, and promote cultural exchanges.





Commission on Human Rights and Administrative Justice (Takoradi, Ghana)

Kristin Brandt (1L) will be assisting the Commission in investigating claims of human rights violations and promoting anti-corruption strategies. CHRAJ focuses on preventing abuses of power and public funds by providing free legal advice to Ghanaians.

Alison Rabe (3L) will assist communities to protect, enforce and defend their customary land rights and support equitable and empowered community – investor partnerships. She will also advocate for a policy regime on land, environment and investment that is equitable and sustainable.
