


INTERESTED IN BIG (OR BIGGER) LAW?

Our graduates accepted positions with many of the preeminent global law firms, as evidenced by William & Mary's #24 ranking in the 2016 edition of the *National Law Journal's* "Go-To Law Schools" (based on percentage of graduates joining the 100 largest U.S. based law firms as ranked by the NLJ). Our graduates also do well when it comes to post-graduate judicial clerkships. For our Class of 2014, William & Mary was among the top 25 of U.S. law schools for the percentage of our graduates who served in federal judicial clerkships. Nearly 17% of the Class of 2015 (30 out of 178) accepted judicial clerkships (6% federal, 11% state). Members of this class are or will be serving as clerks in courts across the country, including:
