## • Fingerprinting Services

The William & Mary Police Department provides free, digital fingerprinting services for students who will be applying for bar admission. Students should call ahead to the Department's non-emergency line at (757) 221-4596 to ensure an officer will be available. The process takes approximately 20 minutes and does not involve ink.
