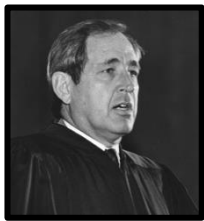
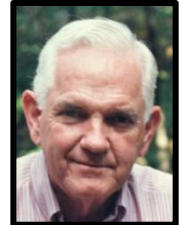




Class Notes Summer 2017

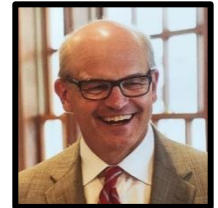

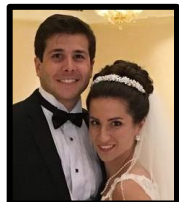

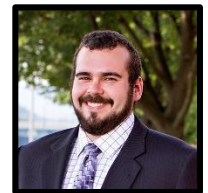
