### April-June 2026

Law Insider call, second Committee calls, Class Letters sent, continue outreach.

### July-Fall 2026

Registration launches, Third Committee calls, second Law Insider call, continue outreach.

### Alumni Weekend: Fall 2026

## Committee Member Role

Reunion committee members play a key role in the Law School's alumni engagement and outreach efforts, serving as invaluable ambassadors of the Law School and the Dean's vision. Through the gift of time, these 5-10 members of a reunion class work with William & Mary Law School Advancement staff to engage their classmates, generate interest in Reunion Weekend, and bolster support for the Law School through the reunion class giving goals.

Committee members dedicate an average of two (2) hours per month to committee work. Law School Advancement staff will work with you, providing the materials and support to enrich your outreach.

By serving on your reunion committee, you build stronger ties to W&M Law and the Law School community--we hope you join the committee and help enhance this year's reunion efforts!

## Responsibilities

- Demonstrate your support and help drive your reunion class participation giving with a multi-year leadership commitment:
  - Consider Dean's Council or a five-year pledge to set your class up for success
  - Make your personal contribution to support your reunion class gift by December 31, 2025
- Attend roughly three to four (3-4) virtual committee meetings over the course of the year
- Connect with up to 10 classmates and encourage them to:
  - Attend Reunion Weekend
  - Make a personal gift to the Law School and lend their support to the class giving goals
- Make every effort to attend Alumni Weekend in the fall, date to be announced in early 2026
