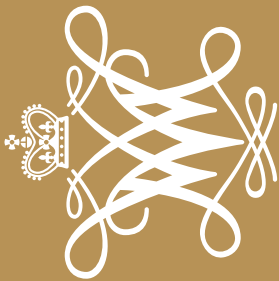
INTERESTED IN BIG (OR BIGGER) LAW?

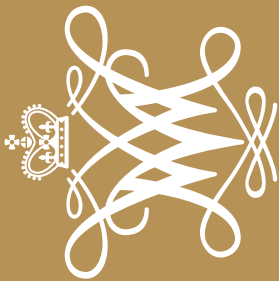

THINKING ABOUT A JUDICIAL CLERKSHIP?

Our graduates also do well when it comes to post-graduate judicial clerkships. For our Class of 2015, William & Mary was among the top 25 of U.S. law schools for the percentage of our graduates who served in federal judicial clerkships. Nearly 17% of the Class of 2015 (30 out of 178) accepted judicial clerkships (6% federal, 11% state) and more than 17% of the Class of 2016 (39 out of 225) accepted judicial clerkships (6% federal, 11% state).
